The progress of the Center over the past four years is directly attributable to your leadership, and we sincerely thank you for your management of NCMRR's efforts.

We also greatly appreciate your enthusiasm and tireless work to revitalize the role of the Rehabilitation Research Coordinating Committee at NIH. Over the years, the DRRC has heard from Institute leaders throughout NIH that your guidance has contributed greatly to the advancement of the field and the improvement of the Committee's efforts. Similarly, your participation in the Interagency Committee on Disability Research has been essential to maintaining focus and effective action by that Committee, and we eagerly await the development of the government-wide inventory on disability, independent living, and rehabilitation research, a project in which we understand you have been instrumental.

We know that you will continue to serve the disability and rehabilitation community in your expanded duties, and we look forward to our upcoming meeting on October 30<sup>th</sup> to congratulate you in person. Thank you again for all you have done to improve the lives of Americans with disabilities and chronic conditions, and to enhance the field of medical rehabilitation and disability research.
